Report: Request to Approve Purchase of AJA Bridge Live

Purpose

CTV is requesting board approval to purchase an **AJA Bridge Live** system, a contribution encoder that allows us to send and receive multiple broadcast-quality video feeds. The equipment cost, including installation, shipping, and tax, is **\$25,332.83**.

Why Purchase Now

- Strategic Timing for Installation: Engineer Nick Brandt, who is highly qualified to install the system, will be in California from October 14–16. His availability eliminates the need for additional travel expenses, reducing costs.
- Multiple Immediate Uses: While originally explored for our Spanish captioning/dubbing service, this equipment solves other pressing broadcast needs right away.

Benefits

- Improved Programming Delivery
 - Solves ongoing issues with delivering Classic Arts Showcase and Free Speech TV.
 - o Enables CTV to receive high-quality feeds such as the *Panetta Lecture* Series.
- Enhanced Community and Institutional Partnerships
 - Facilitates two-way remote telecasts with networks and broadcasters (e.g., CBS in New York interviewing a UCSC scientist).
 - o Creates potential new revenue streams
- Accessibility & Inclusion
 - Supports our upcoming Spanish captioning and dubbing service, aligning with county accessibility goals and available special funding.
 - Has the backing of Tammie Weigle, County Information Services
 Director, with final approval expected from the Clerk of the Board.

Financials

- Total Investment: \$25,332.83
- Funding Context: County has earmarked accessibility funds for projects like this; price point has been reviewed and supported by County Information Services.

Recommendation

CTV staff strongly recommend the board approve this purchase now to:

- 1. Take advantage of cost savings by scheduling installation during Nick Brandt's October visit.
- 2. Begin using the equipment immediately for multiple community and programming benefits.
- 3. Position CTV to launch the Spanish language captioning/dubbing service as soon as county approval is finalized.

Approval Request: Purchase of AJA Bridge Live

CTV requests approval to purchase an **AJA Bridge Live contribution encoder** for **\$25,332.83** (equipment, installation, shipping, tax). While originally intended for our Spanish captioning/dubbing service, the equipment will also immediately solve technical issues with program delivery (*Classic Arts Showcase*, *Free Speech TV*), allow CTV to receive programming feeds such as the *Panetta Lecture Series*, and enable two-way remote telecasts with national broadcasters — creating new revenue opportunities.

This timing is strategic: engineer Nick Brandt will be in California from **October 14–16**, allowing us to complete the installation without travel expenses. The purchase also positions us to move quickly once the county finalizes approval and funding for the Spanish accessibility service. Staff recommend approval at this time.
